Sub : Reimbursement of OPD/IPD treatment to employees/retired employees - regarding.

Reference is invited to this Office Circulars of even No. 1212 dated 06.11.2020 and No. 495-501 dated 15.04.2021 regarding treatment of RRCAT CHSS beneficiaries for emergency/COVID-19 related disease in non-empanelled hospitals and reimbursement of expenditure claimed therefore by the employees.

2. In continuation to the facilities extended to the RRCAT CHSS beneficiaries allowing them to avail emergency treatment for COVID-19 infection in non-empanelled private hospitals in a situation where beds in the empanelled hospitals are not available, it has also been decided with the approval of the competent authority that employees/retired employees and their eligible family members may take OPD/IPD treatment for COVID-19 related infections from any of the following:


- (i) Authorised Medical Attendant (AMA) whose qualifications are recognized under the Indian Medical Council Act, 1956;
- (ii) Government hospitals and medical institutions of the local authorities such as District Hospitals, Medical colleges, Municipal Hospitals, etc.;
- (iii) Private Hospitals as recognised by the Ministry of Health & Family Welfare, New Delhi;
- (iv) Hospitals recognised under CGHS;
- (v) Hospitals recognised by DAE for treatment under CHSS Rules; and
- (vi) Hospitals recognised by the Public Sector Undertakings under the control of DAE and those recognised by concerned State Governments, other Central Government Departments.

3. The beneficiaries may please note that expenditure towards the above treatment will be borne by them. The expenditure so incurred will be reimbursed to them on submission of medical claim form by them in the prescribed proforma to RRCAT Medical Centre, RRCAT as per CS (MA) Rules in case of serving employees and as per CGHS rates in case of retired employees or actual whichever is less. The claim for medical reimbursement must be submitted alongwith necessary documents viz. prescription, original receipts/vouchers/cash memos duly counter signed by the AMA/Hospital authorities with original stamp and discharge summary/certificate with complete details of the treatment administered duly countersigned by the AMA/hospitals.
