These benefits are provided in view of special status of the Department and are reviewed by the Government from time to time.
Minimum qualifications	M.B.B.S. with 01 year relevant experience after obtaining the requisite qualification. Mandatory internship will not be counted as experience. Candidates with institutional experience will be preferred.
Desired Experience	Candidates with casualty experience and worked as General Duty Medical Officer / General Practice will be preferred. Basic computer knowledge is desired.
Age	Maximum 38 years (including age relaxation for OBCs)
Selection Process	Selection will be made on the basis of Personal Interview

Only date of birth indicated in Matriculation Certificate / Municipal Birth Certificate will be accepted. No subsequent request for change shall be entertained.

## **RELAXATION IN UPPER AGE** :

- Relaxation to Ex-Servicemen will be provided as per rules.
- Relaxation to Persons with Disabilities (PWD) will be provided as per rules.
- Relaxation in the upper age limit of 05 years shall be admissible to persons who had ordinarily been domiciled in Kashmir division of the state of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989 provided that the relaxation in the upper age limit for appearing at any examination shall be subject to the maximum number of chances permissible under the relevant rules. Any person intending to avail of this relaxation of age limit shall submit a certificate from (a) the district magistrate the Kashmir division within whose jurisdiction she had ordinarily resided; or (b) any other authority designated in this behalf by the Government of J & K during the period from 1.1.1980 to 31.12.1989.
- Relaxation in the upper age limit of 05 years shall be admissible to children / family members of those who died in the 1984 Riots. Proof of the effect that they have been affected by 1984 Riots should be furnished.
- Upper age limit is Relaxable for a period of 05 years for Central Government Civilian employees having 03 years regular experience in same line or allied cadre.

## **GENERAL INSTRUCTIONS**

- 1. Candidates not possessing prescribed educational qualifications/required experience on closing date of submission of application, will not be eligible and need not apply.
- 2. Only screened-in applicants will be called for interview.
- **3.** Candidate, selected against the anticipated vacancy will not have right to claim against the current vacancy. Their appointment will be solely depending upon the requirement and validity of the select panel.
- **4.** Applications which are not in conformity with the requirements indicated in the advertisement or if the requisite documents / signature / photograph are not uploaded, the application will be summarily rejected. No correspondence will be entertained with the candidates not selected for interview.
- 5. The applicants will be interviewed on the basis of information furnished by them in their application form. They are therefore advised to ensure that they fulfill all eligibility conditions before applying, in case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfill any of the eligibility condition, the candidature of such applicant will be cancelled and no correspondence in this regard will be entertained. Issuance of Call Letter for interview will not confer any right for appointment. Appointment will be solely subject to fulfillment of all eligibility conditions.
- **6.** OBC/PWD Certificates should be as per the prescribed format for employment in Government of India which are uploaded with this advertisement.
- 7. The candidates belonging to OBC/PWD should clearly indicate the same in the application and should attach proof of the same in specified format, failing which their candidature will not be accepted. In case of OBC candidate, the certificate should specifically indicate that the candidate does not belong to any of the creamy layers mentioned in DoPT OM No. 36033/1/2013-Estt.(Res.) dated 27.05.2013.
- 8. RRCAT will be at liberty to reject any application at any stage of the recruitment process if the candidate is found ineligible for the post and no correspondence in this regard will be entertained. The decision of RRCAT shall be final in deciding the eligibility of the candidate.
- **9.** RRCAT reserves the right to fill up the post or even to cancel / restrict / modify / alter the whole process of recruitment without issuing any further notice or assigning any reason thereof.
- **10.** The vacancies shown above are subject to variation. The filling up of vacancies indicated in the advertisement is also subject to approval of Competent Authority and may not be filled up if decided otherwise in terms of the orders issued by the Government of India from time to time.
- **11.** Candidates selected against this advertisement are likely to be posted at RRCAT, Indore but are liable to serve in any part of India and in any constituent unit of the Department of Atomic Energy.
